

## Draft Published for Fourth Recommendation to Amend REACH Authorization List

On February 20, the European Commission issued the draft regulation for fourth amendment of the REACH authorization list. It includes 9 substances from the SVHC (Substance of Very High Concern) candidate list and if the commission adopts the draft, the authorization list will expand from 22 substances to 31 substances. Decision making deadline is set to June 4, 2014

Meanwhile, on February 10, ECHA (European Chemical Agency) handed its fifth REACH authorization recommendation list to the European Commission, which includes 5 substances. Comments and opinions were received from public consultation and Member State Committee and were taken into consideration. The European Commission will be evaluating suitability of each substance in collaboration with Member States and the European Parliament.
