

## 9 Substances Added to the REACH Authorization List

In the Official Journal published on 19 August 2014, the European Commission announced Regulation (EU) No 895/2014, an amendment to the REACH Authorization List. 9 substances from the Substance of Very High Concern (SVHC) candidate list were added to the REACH Authorization List, therefore, increasing the total number of substances in the list from 22 to 31.

The European Commission also considered including N,N-Dimethylacetamide (DMAC, Toxic for reproduction category 1B) in the Authorization List, but inclusion of the substance was postponed, because of its similar intrinsic properties to N-Methyl-2-pyrrolidone (NMP). NMP is currently being reviewed for restriction and the EC means to ensure a consistent regulatory approach to both substances with further consideration.
